Admission Arrangements for th academic year 2025/2026



St Thomas More Catholic First School is part of the Our Lady of the Magnificat MAC. The admissions authority for the school is the Board of Directors of the Our Lady of the Magnificat MAC who has responsibility for admissions to this school. The Boar Directors has delegated responsibility for the administration of the admissions process to the Local Governing Body of St Thomas More Catholic First School.

The admissions process for St Thomas More Catholic First School is part of the Worcestershire Local Authority coordinated admissions scheme. To apply for a place at St Thomas More Catholic First School in the normal admissions round, an application mbst made using the school admission application process of the local authority in which you live naming St Thomas More Catholic First School on the application form. Applications need to be made by 15 nuary 2025. A Supplementary Information (SIF) must also be completed and returned directly to the school by the same date (see Note 2).

All applications which are submitted on time will be considered at the same time, after the closing date.

You will be advised of the outcome of ycapplication on 16 April 2025, or the next working day, by the local authority on behalf of the school.

Please note that throughout this policy, the term parent means all natural parents, any person who is not a parent but has parentatesponsibility for a child and any person who has care of a child.

The ethos of this school is Catholic. The school was founded by the Catholic Church to provide education for children of Catholic families. Whenever there are more applications than places available, priority will be given to Catholic children in accordae with the oversubscription criteria listed below. The school is conducted by its Board of Directors as part of the Catholic Church in accordance with its Articles of Association and seeks at all times to be a witness to Our Lord Jesus Christ.

As a Catholic school, we aim to provide a Catholic education for all our pupils. At a Catholic school, Catholic

fully supported by all families in the school. We therefore hope that all parents will give their full, unreserved and positive support for the aims and ethos of the school. This does not affect the right of an applicant who is not Catholic to applya for be admitted to a place at the school in accordance with these admission arrangements.

The Local Governing Body acts for the Board of Directors who is the admissions authority and has responsibility for admissions to this school. The Local Governing Body has set its Published Admission at 45 pupils to be admitted to the Reception class in the school year which begins in September 2025. (See Note 1 below)

Where there are more applications for places than the number of places available, places will be offered according to the following order of priority. If there is oversubscription within a category, the Local Governing Body will give priority to childring closest to the school determined by the shortest distance (see Note 5).

For the purposes of this policy, a looked after child living with a family where at least one of the carers is Catholic will be considered as Catholic. The carer must forward a copy of their own Catholic or Reception certificate directly to the school in order flois priority to be given to the child as failure to do so will result in the looked after child being ranked as a-Catholic.

Note 4 For all applicants the definition of a brother or sister is:

Where a place is offered in the school, the pupil will be entitled to take up that place, ontianfulbasis in the September following their fourth birthday.

A child may take up a patime place until later in the school year, but not beyond the point at which the child reached compulsory school age.

Upon receipt of the offer of a place a parent should notify the school, as soon as possible, that they wish -time place.

Any reception class place offered following an application made for the 2025/2026 admission round will be withdrawn if the child does not take up that place by the first day of the meanterm 2026.

APPLICATIONS FOR CHILDREN TO BE ADMITTED INTO A CLASS OUTSIDE OF THEIR NORMAL AGE GRO Parents have the right to request, but not insist, that their child be considered for admission to a class outside of their normal age group. This could be the case, for example, if a child is gifted and talented, has

APPLICATIONS OTHER THAN THE NORMAL INTAKE TO RECEPTIONED AS DIVINS SIONS)
